### 2.2 Awareness through Media Programs:

AcA is using social media platforms to raise awareness and transfer the values. The founder **Mr. Bharat Jangam** has a regular talk program “Kalo Surya” aired two times in a week in Yoho

television and also he participates in various talk shows in other television programs as well.



### 2.3 “Sadachar Deep Samman” award program:

From 2079B.S, AcA has initiated an award program to felicitate 4 non corrupt personnel from the field of Judiciary, Bureaucracy, Journalism and Politics respectively. The awardee is selected by a committee

on the merit basis of being morally, ethically and financially clean and virtuous. This award is scheduled on 10<sup>th</sup> Mangsir of



every year.

### 2.4 Awareness through Public Campaigns and Mass Movements:

Anticorruption Academy has been conducting various public campaigns and mass movements since its establishment.
